CLAIM

The Plaintiff claims :

Against the First, Second, Third, Fourth, Fifth and Sixth Defendants jointly and severally :

1. General compensatory damages in the amount of \$375,000 for defamation;
2. Aggravated compensatory damages in the amount of \$370,000 for defamation;
3. Interest on damages, pursuant to section 58 of the Civil Proceedings Act 2011 (Qld);
4. A permanent injunction to restrain all the Defendants, whether by the directors, officers, servants or agents or otherwise howsoever from continuing to publish, further publish or causing to be published, the same or similar words that are false and defamatory of the Plaintiff;
5. Alternatively, a permanent injunction under section 232 of Schedule 2 of the Competition and Consumer Act 2010 restraining all the Defendants from causing any matters to be published regarding the Plaintiff, that are misleading or deceptive or likely to be misleading or deceptive;

6. An order that within 28 days the Defendants publish at their own expense, to the extent equal to their publications of :
 - (a) the Offending Material contained in the First and Second Blogs; and
 - (b) the 115,596,000 Offending Hyperlinks and photographs; and
 - (c) the Press Release; and
 - (d) the Archive Index and appended pages;identifying the falsity of the matters published and an apology for having made them, and to be in a form that prior to publication is first provided to the Plaintiff for approval;
7. Other or further orders as the Court deems appropriate;
8. Costs for filing and service fees and out of pocket expenses.

The Plaintiff makes this claim in reliance on the facts alleged in the attached Statement of Claim.
